## WARRANTY

Mint Turbines LLC (MTL) represents and warrants that its workmanship conforms to the intent of the requirements of the manufacturer; that its quality is in accordance with the requirements of ISO 9001:2008 & AS9100-B management system standard for the In-House Maintenance, Repair and Overhaul of Aircraft Engines and Gearboxes and in compliance with Federal Aviation Regulations Part 145.

- ⇒ PT6A Engines / PT6T Power Sections overhauled by MTL are warranted to be free of defects for a period of 1,000 operational hours or 2 years from Warranty Date, whichever comes first.
- ⇒ PT6T Combining Gearboxes overhauled by MTL are warranted to be free of defects for a period of 1,000 operational hours or 1 year from Warranty Date, whichever comes first.
- ⇒ PT6A Engines / PT6T Power Sections repaired by MTL are warranted to be free of defects on work performed for a period of 250 operational hours or 6 months from Warranty Date, whichever comes first.
- ⇒ PT6T Combining Gearboxes repaired by MTL are warranted to be free of defects on work performed for a period of 250 operational hours or 6 months from Warranty Date, which-ever comes first.


The warranty is extended to the customer that originally contracted MTL to perform the overhaul or repair. The warranty may be transferred to another person, corporation, or customer anywhere in the world if MTL is notified in writing prior to or at the time of the transfer of ownership. Consent for warranty transfer must be in writing from an authorized MTL representative.

The parts warranty coverage offered by MTL shall only apply to time continued and reworked materials embodied at its facility. Fuel controls, governors, accessories, and components repaired by third party vendors will carry only the warranties as provided by the 3rd party vendor. MTL will administer warranty claims on behalf of the engine owner/operator for all OEM and 3rd party supplied new or repaired parts, components, and accessories as governed by their respective service policies and/or warranties.

Original parts inspected, repaired, and re-embodied in the owner/operators engine are warranted to be free of defects when installed by MTL. Degeneration of these parts discovered during the warranty period are not warranted and are the responsibility of the engine's owner/operator. This includes time life/cycle used components installed in time life/cycle continued condition.

In the event MTL determines the warranty claim to be valid, MTL will, at its expense, either repair or replace, **at its facility** the nonconforming portions of the unit which have sustained damage as a direct result of the nonconforming work or part. Engines, modules, accessories or parts, shall be returned to the Customer at MTL's Expense. Lease units are subject to availability with lease and operating charges at the customer's expense and will be based upon normal lease rates.

In the event that the warranty claim is denied, the engine, module, accessories or parts shall be returned to the customer C.O.D. and the cost of disassembly and reassembly to disclose the claimed defect and the cost of preparation of any technical report shall be borne by the Customer at MTL's current applicable

hourly rates. The Customer shall pay all shipping costs associated with the denied warranty claim.

### Additional Terms

- Defects in workmanship must be discovered before expiration of the warranty and MTL must be promptly notified of the defect in writing within 72 hours of discovery.
- The Unit must be returned to MTL's facility after notice of failure has been given and MTL must be afforded the opportunity to perform corrective work at its facility.
- The Unit must have been installed, preserved, maintained and operated in accordance with the manufacturer's directives and instructions; the unit must not have been altered or repaired outside of MTL's facility; the unit must not have been subjected to abuse, misuse, or neglect; been involved in an accident, incident, fire, or have sustained damage from the elements, or been damaged by foreign object debris, electrical arcing, or repair / alteration by another maintenance facility.
- MTL shall have the option to replace warranted life & cycle-limited parts with either new parts or with parts with at least the same life remaining.
- All parts, whether new, serviceable or overhauled must have been supplied and installed by MTL. **Customer supplied parts are specifically excluded from this warranty!**

This warranty is in lieu of all other warranties expressed or implied and all other obligations and liabilities either direct or consequential on the part of MTL, all of which are hereby expressly disclaimed. No one may expand the scope, coverage or terms of this warranty beyond the terms specifically set forth herein. MTL neither assumes nor authorizes any person to assume for it, any other liabilities in connection with its products and / or services except as expressed in a written agreement entered into by MTL. This warranty does not include, and MTL will not be liable for, any other remedy or liability for incidental or consequential damages of any kind, including but not limited to such damages resulting from a breach of contract or warranty, alleged negligence, damage to airframe or other property, costs or expenses or operation of unit, unit module, or unit component or other equipment, loss of the use of the aircraft, cost of capital, cost of substitute equipment, facility or services, downtime costs, or claims of customers, buyer(s) or third parties for such damages, or any other loss, claim or demand of any description. The registered owner must notify Mint Turbines LLC of a request for warranty coverage consideration within 72 hours of detection of a problem suspected to be warranty related. Resolution of warranty claims will be subject to the laws of the State of Oklahoma and the United States of America. Failure to comply with the terms and conditions stated herein will result in the invalidation of any warranty coverage.
